I agree to the following consent provision in regard to "Taxable Status of Patronage Dividends":

Each person who hereafter applies for and is accepted to membership in this Cooperative, and each member of this cooperative on the effective date of this By-law who continues as a member after such date shall by such act alone, consent that the amount of any distributions with respect to his patronage occurring after 1962, which are made in qualified written notices of allocation (as defined in Internal Revenue Code Section 1388 (c)) and which are received by him from the Cooperative, will be taken into account by him at their stated dollar amounts in the manner provided in Internal Revenue Code Section 1385 (a) in the taxable year in which such qualified written notices of allocation are received by him. Further, if this Cooperative should distribute a non-qualified written notice of allocation (as defined in Internal Revenue Code Section 1388 (d)) each member of this Cooperative likewise, consents to take into account on the date of redemption the value of the proceeds so received.

I acknowledge receipt of a current copy of the By-laws.

It is understood that, if approved by the Board of Directors, I will be admitted with full right of membership as soon as **\$25.00 has been paid in cash or check.**
